OLW School has provided a Catholic education in this community since 1954 and our commitment to creating a well-rounded young person of faith has remained steadfast. Our Lady of the Wayside School is dedicated to enriching our students' minds, fostering a deep and meaningful faith in each child, and expanding their talents. We are so grateful for this parish and school community: teachers and administrators, students and parents, alumni and parishioners, and community partners. Throughout the fiscal year 2017-18, the school received donations for three funds that directly support only OLV School.

## **Annual Fund**

The OLV School Annual Fund is an unrestricted fund that is used to maintain technology, update curriculum materials, provide professional development opportunities, & enhance our students' excellent academic and faith-filled education. In 2017-18, the Family School Association donated over \$190,000 to the Annual Fund, some of which was designated for the renovation of the library into a multi-purpose room. An additional \$20,000 was raised through other fundraising efforts.

## **Endowment & Rebek Funds**

The OLV School Endowment Fund was established in 1999 to perpetuate, partially support, and uphold the educational work of OLV School. A strong Endowment Fund helps maintain and stabilize the financial health of OLV to preserve high quality Catholic education. The Endowment Fund had a balance of \$552,879 on June 30, 2018. Over \$24,000 was raised from a targeted fundraising campaign as well as from regular GiveCentral contributions.

The Gloria Rebek Scholarship Fund provides tuition assistance for families who demonstrate financial need. Some families have a one-time need and some apply yearly. For all, providing a Catholic education for their children is important,
