Because of your support and generosity through your time, donations and prayers, Our Lady of Our Wayside schools thrives today.

OLW School is the largest ministry that the Parish supports and a source for Catholic education since 1954. Our teachers and staff dedicate their days to teaching the whole student - enriching their minds, fostering a deep and meaningful faith in each child, and expanding their talents. None of this could be done with our partners in this mission: school parents, school and parish staff, the parish community, and alumni. Their support both emotionally and financially makes a real difference in the lives of the children we serve and we wish to thank and recognize those that supported any of these funds with a direct donation. Our Annual Giving Report list of donors will be published in the bulletin next week.

Three funds directly support the school.

The goal of the **Annual Fund** is to bring additional monetary resources to the school that allow the administration to provide what's best for our students. There are several ways that a strong Annual Fund helps our school. It provides: additional support staff, updated technology in all classrooms, teacher stipends and reimbursements for classroom supplies, and more. In 2018-2019, the Family School Association donated \$130,000 to the fund. Other fundraising efforts raised an additional \$17,000 through #GivingTuesday, the Alumni Appeal, and corporate giving.

The **OLW School Endowment Fund** was established in 1999 to perpetuate, partially support, and uphold the educational work of OLW School. A strong Endowment Fund helps maintain and stabilize the financial health of OLW to preserve high quality Catholic education in our parish.

The Endowment Fund's balance as of June 30, 2019 was \$575,217. Over \$33,000 was raised from a targeted fundraising campaign as well as from regular GiveCentral contributions.

The Gloria Rebek Scholarship Fund provides tuition assistance for families who demonstrate financial need. Some families have a one-time need and some apply yearly. For all, providing a Catholic education for their children is important.

Support can come in many different ways.

Corporate Matching Gifts. As an educational institution, donations made to the three funds that directly support OLW will usually qualify for corporate matching funds. Most companies offer some type of matching gift program.

United Way. If your company participates in an annual United Way giving program, you can designate the OLW Gloria Rebek Fund as the recipient of your donation.

Employee Giving. Many employees make direct donations through their workplace foundations for employee giving.

IL State Tax Credits. By donating to an approved Scholarship Granting Organization that supports Catholic school education, you can lower your state income tax responsibility by 75%. E.G. Make a \$5,000 donation, receive a state tax credit of \$3,750.
