

# OLW School 2016 Annual Giving Report

OLW School is a ministry of Our Lady of the Wayside Parish; it is a community of teachers and administrators, students and parents, alumni and parishioners, and community partners. OLW School has three funds that monetarily support the school and we are grateful for the support of this community.



The **OLW School Annual Fund (Annual Fund)** is an unrestricted fund that is used to maintain technology, update curriculum materials, provide professional development opportunities, and help maintain a safe and clean learning environment.



Because of the **Annual Fund**, in the 2015-16 school year: † Middle school students learned Google docs on iPads, tablets or laptops as an introduction to programs used in high school. † All grades used our different technology offerings to participate in the Hour of Code, a global movement to celebrate computer science. † A social worker was available at school twice a week to work with students in group settings, or one-on-one as needed, to discuss relevant social and emotional topics. † Our dedicated Catholic school teachers get reimbursed for classroom expenses. † Teachers and staff participated in professional development opportunities, a reward for our very dedicated staff.

In addition to the Annual Fund, OLW maintains the **Our Lady of the Wayside School Endowment Fund (OLWSEF)** and the **Gloria Rebek Scholarship Fund (Rebek Fund)**. The OLWSEF is overseen by a nine-member Board of Trustees: members include the Pastor, the Principal and the Chair of the School Advisory Board, plus six trustees, either registered parishioners or graduates of OLW School, who serve appointed three-year terms. Assets of the OLWSEF may be expended by the Board, as limited by the by-laws, solely for the benefit of OLW School and for no other Parish purposes.

The **OLWSEF** is a restricted fund intended to ensure long-term viability and affordability of OLW School. It is managed by the Archdiocese of Chicago in accordance with established archdiocesan policies and procedures for local endowment funds. Value of the OLWSEF was \$441,848 on June 30, 2016 compared with a value of \$465,985 the previous year. (The decrease is due to market conditions.) No disbursements were made in FY 2015-16.



The **Rebek Fund** was established in 1986 in honor of Gloria Rebek, a beloved school secretary and long-time school staff member. The Rebek Fund is an unrestricted fund that is available for immediate use by families who demonstrate financial need. The Rebek Fund receives donations from individuals, organizational gifts, bequests and fundraising. OLW Parish also supports the Rebek Fund with two second collections per year. In 2015-16, 12 students benefited from the Rebek Fund and received a Catholic education at OLW.
