Boosters: We are back to normal finally with games, all are welcome to attend; Prowl was a great success (\$10,000 raised), appreciative of the leadership by James & Jennifer Cummings as well as all the staff and volunteers; The girls' volleyball season is about 1/2 way done and the playoffs for 7th/8th will be first week of Nov with championship games on Nov 6 at St. Viator; Basketball sign-ups are taking place now through Oct 31 for both girls and boys.
